


DIRECTIONS FOR USE

ANTS AND MOLE-CRICKETS IN NON-CROP AND NON-GRAZING AREAS: Apply 1 pt. per acre in sufficient water to give uniform coverage. (One fluid ounce in sufficient water to cover 3,000 square feet.) In the control of ants, special attention should be paid to thoroughly soaking individual ant nest.

CHINCH BUGS and WHITEGRASS in OPEN AREAS, FAIR TURF and LAWNS: Apply 1 to 2 pints per acre in sufficient water to give uniform coverage. Make application at first sign of infestation and repeat in 2 weeks or later if infestation continues. Keep dormant and avoid over-fertilizing. Do not apply to newly seeded areas.

GRASSHOPPER: Apply 1 to 2 pints per acre in sufficient water to give uniform coverage. Repeat application in 2 weeks or later if infestation continues. Do not apply to newly seeded areas.

CRICKETS: Apply 1 to 2 pints per acre in sufficient water to give uniform coverage. Repeat application in 2 weeks or later if infestation continues. Do not apply to newly seeded areas.
