WOOD PRESERVATIVE CONCENTRATE

(Made from Pentachlorophenol)

Wood Preservative Concentrate when properly diluted, is used to control TERMITES, POWDER POST BEETLES, WOOD BORERS and ROT caused by FUNGI.

DIRECTIONS FOR USE:

Dilute one gallon of this concentrate with 10 gallons kerosene, light fuel oil or diesel fuel oil. This diluted solution should be applied to effect maximum penetration and absorption into the wood, particularly where end grains are evident and at joints. Complete immersion of the wood into the diluted solution (open tank treatment) is recommended for 5 minutes per inch of thickness. Wood which is to be in contact with the ground should be dipped or receive two heavy coats. Do not paint or varnish wood that has been treated until it has dried for at least 48 hours. Remove and cut out all unsound wood two feet beyond any visible evidence of decay. Fence posts, poles, foundation timbers and heavy wood members should be free of bark, dry and well seasoned.
