PREMIUM GRADE MALATHION GRAIN PROTECTANT

RECOMMENDATIONS FOR USE:

For the protection of stored grain such as Wheat, Oats, Rice, Corn, Rye, Barley, and Grain Sorghum to control RED FLOUR BEETLE, INDIAN MEAL MOTHS, CONFUSED FLOUR BEETLE, RICE WEEVIL, FLAT GRAIN BEETLE, RUSTY GRAIN BEETLE, LESSER GRAIN BORER, CANARY WEEVIL, and SAW-TOOTHED GRAIN BEETLE use Red-Top Premium Grade Malathion Grain Protectant at the rate of 1 pint in 2 to 3 gallons of water to each 1000 bushels of the grain. Apply as grain is being loaded or turned into final storage. Field and garden seeds can be protected against the above insects with a rate of 1/2 pint of Red-Top Premium Grade Malathion Grain Protectant in 1 to 2 gallons of water per 500 bushels of seed.

To protect stored grains from attack by INDIAN MEAL MOTHS, apply 1/2 pint of clean or uninfested grain 1/2 pint of Red-Top Premium Grade Malathion Grain Protectant in 1 to 2 gallons of water per 1000 square feet of grain surface area. Apply the spray evenly over the surface of the grain. Apply immediately after grain is loaded into storage and repeat if necessary.

For a residual wall, floor, and machinery spray in grain elevators, in treating truck beds, box cars, and ships' holds before loading grain, apply 1 gallon of Red-Top Premium Grade Malathion Grain Protectant per 25 gallons of water making thorough application. Before applying spray, clean elevators and box cars thoroughly. Remove and burn off sweepings and debris.
