Where recommended for prevention of Powdery Mildew, apply when disease first appears and repeat at 7 to 10 day intervals throughout the growing season. Shorten the interval during humid, rainy weather.

Where recommended for prevention of Brown Rot, apply at pink bud or popcorn stage during bloom and at petal fall, shuck split and shuck fall. Repeat at 10 to 14 day intervals in cover sprays as long as necessary.

ALFALFA: For control of Atlantic Mite, Spider Mite, and Clover Mite use 30 to 50 lbs. per acre.

Make a second application when shoots are 12 inches to 15 inches long and the third about 14 days later. Repeat applications at 10 to 14 day intervals to protect new growth. Avoid applications during hot weather as injury may occur. Concord and other labrusca type grapes may be injured by sulfur.

HOPS: For control of Red Spider Mites use 30 to 50 lbs. per acre.

PEACHES: For the control of Peach Silver Mite, Powdery Mildew, and prevention of Brown Rot of fruit apply 40 to 50 lbs. per acro. For prevention of Brown Rot of fruit apply when fruit begins to ripen.
