

THIODAN 5 SULFUR 25 DUST

This product formulated for application by ground or air.

RECOMMENDATIONS FOR USE:

ARTICHOKES: Use 20 lbs. per acre to control **ARTICHOKE APHID** and **GREEN PEACH APHID**. Repeat as needed for control. Do not apply within 7 days of harvest.

BEANS: Use 20 lbs. per acre to control **MEXICAN BEAN BEETLE**, **BEAN APHID** and **WESTERN BEAN CUTWORM**. Do not apply more than 3 times per season. Do not feed treated threashings to livestock or allow livestock to graze in treated fields. Do not use on lima beans that are to be removed from the field for processing. Do not apply within 3 days of harvest.

BROCCOLI, CABBAGE and CAULIFLOWER: Use 15 lbs. per acre to control **CABBAGE LOOPER**, **IMPORTED CABBAGE WORM**, **DIAMOND-BACK MOTH LARVAE**, **CROSS-STRIPED CABBAGE WORM**, **FLEA BEETLE**, **HARLEQUIN BUG** and **STINK BUGS**. Repeat as necessary to maintain control. Do not apply on Cauliflower within 14 days of harvest. Do not apply on Broccoli or Cabbage within 7 days of harvest.

COTTON: Use 30 lbs. per acre to control **COTTON STINK BUGS**, **LYGUS BUGS**, **BOLLWORM** and **CABBAGE LOOPER**. Repeat as necessary to maintain control. Do not apply after bolls begin to open. Do not graze meat or dairy animals in treated fields.

EGGPLANTS: Use 10 lbs. per acre to control **APHIDS**, **FLEA BEETLES**, **COLORADO POTATO BEETLE** and **WHITEFLY**. Repeat as necessary to maintain control. Do not apply within 1 day of harvest.

GRAPES: Use 25 to 30 lbs. per acre to control **GRAPE LEAFHOPPER**. Do not apply within 7 days of harvest. Do not use on Concord variety as injury is likely to occur.

LETTUCE (Head): Use 20 lbs. per acre to control **CABBAGE LOOPER**, **GREEN PEACH APHID**, **DIAMOND-BACK MOTH LARVAE** & **IMPORTED CABBAGE WORM**. Do not make more than 3 applications after thinning. Do not apply within 14 days of harvest. Remove outside leaves at harvest. Do not feed crop waste to livestock.

PEAS (Seed): Use 20 to 24 lbs. per acre to control **PEA APHID** and **PEA WEEVIL**. Do not feed treated vines or threashings to dairy or meat animals.

PEPPERS: Use 20 lbs. per acre to control **FLEA BEETLE** and **GREEN PEACH APHID**. Do not apply within 1 day of harvest.

POTATOES: Use 20 lbs. per acre to control **FLEA BEETLE**, **COLORADO POTATO BEETLE**, **LEAFHOPPERS**, **APHIDS**, **POTATO TUBERWORM**, **LEAF-FOOTED PLANT BUG**, **SOUTHERN ARMYWORM**, **GREEN STINK BUG**, **POTATO PSYLLID** and **EUROPEAN CORN BORER**. Apply as needed to harvest.

SQUASH (Summer and Winter): Use 15 to 20 lbs. per acre to control **APHIDS**, **CUCUMBER BEETLES**, **SQUASH VINE BORERS** and **STRIPED FLEA BEETLES**. For **SQUASH VINE BORER**, apply to flower buds, stems and vines as soon as moths appear. Do not apply more than 20 lbs. per acre. May be applied up to day of harvest.

RECOMMENDATIONS FOR USE: (Continued)

STRAWBERRIES: Use 20 lbs. per acre to control **STRAWBERRY APHID** and **MEADOW SPITTLEBUG**. Do not apply within 4 days of harvest. Do not apply at intervals of less than 15 days or more than twice during any 35-day period.

TOMATOES: Use 20 lbs. per acre to control **COLORADO POTATO BEETLE**, **FLEA BEETLE**, **HORNWORM**, **TOMATO FRUITWORM**, **CABBAGE LOOPER**, **GREEN PEACH APHIDS** and **WHITEFLY**. Repeat as necessary to maintain control. Do not apply within 1 day of picking.

WALNUTS: Use 40 lbs. per acre to control **WALNUT APHIDS**. Repeat as required to maintain control. Do not apply after husk split. Do not graze livestock in treated groves.
