ENGINEERING CONTROLS

Pilots applying applications under the auspices of the Animal and Plant Health Inspection Service (APHIS) Rangeland Grasshopper and Mormon Cricket Suppression Program or related state programs must use an enclosed cockpit in a manner that is consistent with the WPS for Agricultural Pesticides [40 CFR 170.240(d)(6)]. In addition, the cockpit air intake must be located above the bait release point and the bait bin must be completely separate from the cockpit.

This product may be applied only by ground using a mechanical spreader or underground shank applicator. Do not apply by hand, spoon or belly grinder. **EXCEPTION:** Aerial applications only to rangeland are allowed only under the auspices of the Animal and Plant Health Inspection Service (APHIS) Rangeland Grasshopper and Mormon Cricket Suppression Program, and/or allied state programs.
