Dear Mr. Chang:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided that you revise the following:

- 1) On page 1, add the National Organic Product Program labeling statement "For Organic Production" to your product labeling.
- 2) On page 1, "Ingredients Statement" section, replace the phrase "INERT INGREDIENTS" to "OTHER INGREDIENTS".
- 3) On page 1, add the precautionary word "CAUTION." prior to the precautionary sentences "Causes moderate eyed irritation. Harmful if absorbed through..."
- 4) On page 1, in the "PPE" section, replace the phrase "waterproof gloves" with "chemical resistant gloves made of any water proof material."
- 5) On page 1, revise the "PHYSICAL HAZARDS" heading to "PHYSICAL AND CHEMICAL HAZARDS".
- 6) On page 1, in the "AGRICULTURAL USE REQUIREMENTS" box, revise the last paragraph to read, "PPE required for early entry... or water is: A) Coveralls;
 B) Chemical resistant gloves made of any waterproof material; C) Shoes plus socks;
 D) Protective eyewear."
- 7) On page 1, in the "MIXING INSTRUCTIONS" section 1st sentence, delete the word, "recommended" and replace it with the word "specific".

- 8) On page 2, in the "**DIRECTIONS FOR USE**" section for "APPLICATION INSTRUCTIONS:" 1st sentence, delete the word, "should" and replace it with the word "must".
- 9) On page 3, in the "COMPATIBILITY" section revise the second sentence to read, "Because conditions vary, mix a small amount of the pesticide prior to application to examine their compatibility. ALWAYS ADD THE PESTICIDE INTO THE MIXED GOLDEN-DEW. Follow more restrictive labeling of any tank mix partner. Do not tank mix with any product which contains a prohibition on tank mixing."
- 10) On pages 3, 4 and 5, revise the heading "Recommendations for Use" to read, "APPLICATION DIRECTIONS".
- 11) On pages 3, 4 and 5, revise the heading "RATE" within the field crops table to read, "PRODUCT RATE".
- 12) On page 8, in the "STORAGE AND DISPOSAL" section, revise the first sentence of the Pesticide Storage Section to read, "Store in sealed original container in a cool, dry area away from any heat or ignition source."

One copy of the label stamped "Accepted with comments" is enclosed for your records. This label supercedes all labels previously accepted for this product. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.

SPRINKLER CHEMIGATION

- 7) Do not apply when wind speed favors drift beyond the area intended for treatment.

Do not use sulfur with oil or within two weeks of an oil application unless in a dormant, delayed dormant, or postharvest application on pome and stone fruit. For citrus, do not apply within 21 days of an oil spray. When growing crops for processing, consult the processor before applying sulfur. For control of MITES, use the higher rates shown under conditions of high pest pressure. For control of FUNGI, use higher rates shown when weather conditions indicate a potential for increased pest pressure.

Sulfur will cause severe fruit and leaf injury to sulfur sensitive crops. Do not allow this material to drift into sulfur sensitive melons, squash, cucumbers, apricots or other plants which may be injured by sulfur.

WILBUR-ELLIS recommends the use of a surfactant such as Sylgard 309 to improve coverage.
