GENERAL INFORMATION

NU-FLOW D is recommended for use at time of planting as a supplemental seed treatment to protect against seed/seedling rots, damping-off and soreshin (caused by Rhizoctonia, Pythium), which impair good seed germination and seedling development of cotton and beans. NU-FLOW D is a ready-to-use flowable designed to be pumped or poured directly into the seed treater.

NOTE: Federal law requires that bags containing treated seed shall be labeled with the following information: "This seed has been treated with NU-FLOW D fungicide. Do not use treated seed for food, feed or oil purposes. In California, do not graze plants grown from treated seed. In other areas, do not graze treated beans within 45 days of planting."

Always use NU-FLOW D with an EPA-approved dye or colorant that imparts an unnatural color to the seed.

Apply NU-FLOW D at the rate of 4.0 to 17.6 fl. oz. per 100 lbs. of acid-delinted, reginned, or fuzzy cotton seed (in California use a minimum of 11.4 fl. oz. per 100 lbs.), 7 fl. oz. per 100 lbs. of beans.

Use only higher rates under conditions of high pest pressure. Lower rates may give reduced efficiency.

NU-FLOW D may be diluted with water provided the recommended amount of product is applied.

Do not use in a manner that will contaminate feed or foodstuffs.
