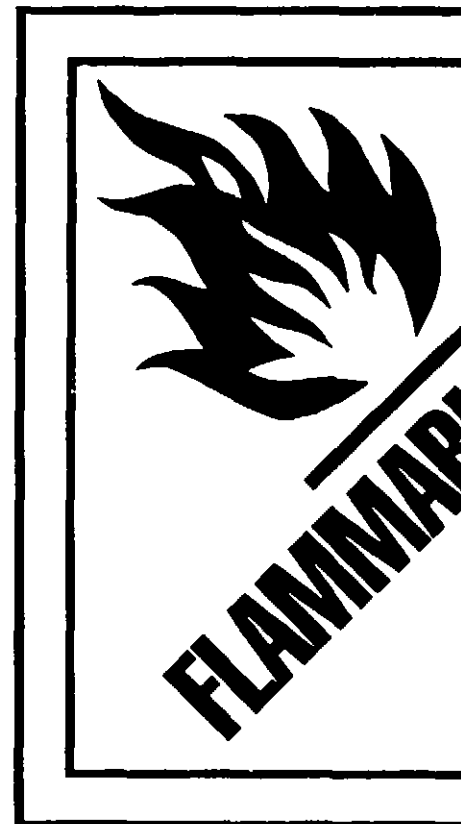

Note: It may be necessary to add up to equal parts of water to assure optimum coat coverage.

BARLEY	2-4 oz./bushel	Covered Smut
OATS	2-4 oz./bushel	Oat Smut
WHEAT	2 oz./bushel	Common Smut or Bunt and Damping-off caused by Rhizoctonia
COTTON	Acid delinted 12 oz. lbs.	Seed rot and early stages of Pre-emergence damping-off
	Mechanically delinted 16 oz. lbs.	Rhizoctonia

Use higher rates under conditions of high pest pressure. Lower rates may reduce efficiency.

If the history of diseases has been severe, then this treatment on cotton seeds may give only temporary protection and a subsequent soil application may be required to control later stages of post-emergence damping-off.
