

#### STATEMENT OF PRACTICAL TREATMENT



### STORAGE AND DISPOSAL

- Prohibitions: Do not contaminate water, food or feed by storage or disposal.
- 2. Storage: Store in a cool, dry place.
- 3. Pesticide Disposal: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. WHEAT and BARLEY: For control of common root rot (Helmin-thosporium sativum) and barley leaf strip, use 0.8 to 1.5 fl. oz. of Nu-Zone 10ME per 100 lbs. of seed. Use the higher dosage rate when disease pressure is severe.

COTTON: For control of Fusarium and Thielaviopsis use 4 to 8 fl. oz. Nu-Zone 10ME per 100 lbs. of seed.

For ready mix treaters, Nu-Zone 10ME may be applied directly to the seed.

For slurry treaters, Nu-Zone 10ME may be diluted with water, not to exceed 7 fl. oz. additional water per 100 lbs. of wheat and barley seed or 20 fl. oz. water per 100 lbs. of cottonseed.
