**PRECAUTIONARY STATEMENT****HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

CAUTION: Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist and provide adequate ventilation of area being treated. Avoid contact with skin, eyes, and clothing. In case of contact immediately flush skin and eyes with plenty of water. Remove pets, birds and cover fish aquariums before spraying. Do not allow children or pets to contact treated surface until spray has dried.

STATEMENT OF PRACTICAL TREATMENT

If swallowed drink one or two glasses water and induce vomiting by touching the back of the throat with finger. Repeat until vomiting fluid is clear. Call a physician immediately. Do not induce vomiting or give anything by mouth to an unconscious person. If inhaled remove victim to fresh air. Apply respiration if indicated. If on skin remove contaminated clothing and wash affected area with soap and water. If in eyes flush with plenty of water. Call a physician if irritation persists.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine, by injection, is antidote of choice.

ENVIRONMENTAL HAZARDS

Do not use in commercial food processing or preparation areas. In the home, all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. This product is toxic to fish, birds, and other wild life. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

Do not use or store near heat or open flame.

STORAGE AND DISPOSAL

STORAGE: Store in cool dry area away from heat or open flame. **DISPOSAL:** Do not reuse empty can - nor. Wrap container and put in trash collection.

Use Wilbur-Ellis Ready To Use Ant, Roach, Flea & Spider Spray as a spot treatment to control cockroaches, fleas and other insects listed below. Apply this product as a coarse spray to localized areas where pests are found or may occur. Spray surface until wet. Repeat as needed. **TO KILL COCKROACHES, ANTS, CRICKETS AND SPIDERS:** Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks and crevices in walls, along baseboards and floor and window frames, behind and beneath sinks, stoves, refrigerators and cabinets and around garbage cans, plumbing, and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails also around doors and windows and wherever else these pests may find entrance. Repeat as necessary. **TO KILL FLEAS:** Thoroughly apply as a spot treatment to infested areas such as pet beds and nesting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Do not spray pets with this product. Treat pets with a product registered for animal application to control the source of the flea infestation.
