Do not apply at wind speeds greater than 15 mph at the application site.

If applying at wind speeds less than 3 mph, the applicator must determine if a) conditions of temperature inversion exist, or b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

### **GROUND APPLICATION**

Apply using a nozzle height of no more than 4 feet above the ground or crop canopy.

Do not apply at wind speeds greater than 15 mph at the application site.

Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

For airblast applications turn off outward pointing nozzles at row ends and when spraying outer row. To minimize spray loss over the top in orchard applications, spray must be directed into the canopy.

### **AERIAL APPLICATION**

SPRAY DRIFT MANAGEMENT (continued)

For aerial applications of agricultural products, do not release spray at a height greater than 10 feet above the ground, top of crops, or above the orchard canopy.

The boom length must not exceed 75% of the wingspan or 90% of the rotor blade diameter.

When applications are made with a cross-wind, the swath will be displaced downwind. The applicator must compensate for this displacement at the downwind edge of the application area by adjusting the path of the aircraft upwind. Leave at least one swath unsprayed at the downwind edge of the treated field

Do not apply at wind speeds greater than 15 mph at the application site.

Apply as a medium or coarser spray (ASABE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

### **USE RATES**

### **SPRING OR SUMMER SPRAY**

CITRUS: For control of Florida red scale, California red scale, chaff scale and purple scale, white flies (intermediate forms), Texas citrus mite and citrus red mite -- Apply 5 to 8 gallons of Citri-Oil per acre. Do not apply within 30 days before or after application of sulfur. Do not apply to trees that are under moisture stress. Do not apply during periods of excessive high temperatures (above  $90^{\circ}$  F) or periods of low relative humidity ( $20^{\circ}$ ).

Do not apply more than 8 gallons of this product per acre.

### **DORMANT SPRAY**

**PEACHES & PLUMS:** For control of San Jose scale and white peach scale — Apply 3 to 4 gallons of Citri-Oil per 100 gallons of water. Apply during dormancy when temperature is between 50-70°F. In the case of very severe scale infestation, two applications may be needed. Make the first application soon after dormancy begins. Wait at least six weeks and check for live scale; if present, make a second application. Improved efficacy will be obtained if temperature is above 60°F and the sun is shining at the time of application, but buds are not yet burst to any extent.

**PECANS:** For control of obscure scale -- Apply 3 to 3-1/2 gallons of Citri-Oil per 100 gallons of water.

Application should be made during free dormancy and when temperature is between 50-70°F.

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **Pesticide Storage**: Store in original container only and keep sealed. Store in closed storage areas. Use caution when moving, opening, closing or pouring.

**Pesticide Disposal:** Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

### Container Disposal:

Refillable Container (110 gallons or greater): Refill this container with pesticides only. Do not reuse this container for any other purpose. Repeat this procedure two more times. Once cleaned, some agricultural plastic pesticide containers can be taken to a container collection site or picked up for recycling. To find the nearest site, contact your chemical dealer or manufacturer, or contact Ag Container Recycling Council (ACRC) at 877-952-2272 or rperkins@ acrecycle.org. If container is not to be recycled, offer it for reconditioning or puncture and dispose of it in a sanitary landfill; or by incineration; or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

**5 gallon Nonrefillable container:** Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip.
