**CAUTION**

Harmful if swallowed. May cause irritation of nose, throat, eyes, and skin. Protective clothing (long pants, long sleeve shirts, gloves, hat and boots) must be worn during mixing and loading. Use of rubber gloves is recommended. Avoid inhalation of any dust from treated seed. **STATEMENT OF PRACTICAL TREATMENT**

If swallowed, induce vomiting by drinking 1 or 2 large glasses of water and then touch back of throat with finger. Repeat until vomit fluid is clear. Get medical attention. If in eyes, flush with clean water for at least 15 minutes and then get medical attention. If on skin, wash with soap and water.

**ENVIRONMENTAL HAZARDS**

This product is toxic to fish. Do not apply directly to water or wetlands. Do not contaminate water by cleaning of equipment or disposal of wastes. Exposed treated seeds may be hazardous to birds and other wildlife. Dispose of all treated seeds by burial away from bodies of water.

**PRODUCT INFORMATION**

GRANOX Plus Flowable is a special seed treatment formulation of maneb and thiabendazole fungicides which, when used at the correct dosage rate, protects wheat against the seed-borne disease Stinking Smut (Bunt) of wheat. It also protects wheat against certain seed and soil-borne diseases causing Root Rot and Seedling Blight.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STIR WELL BEFORE USE. Use at temperatures above 0°F.

Use GRANOX Plus Flowable in liquid and slurry seed treaters at the following rates:

Wheat - 1.6 fl. oz. per bushel

Use only recommended rates - lower amounts may not give the desired control. Higher amounts may cause seed injury. Seed should be well cured, dried and cleaned before treatment. For maximum benefits avoid deep seeding and exceptionally early sowing under poor growing conditions.

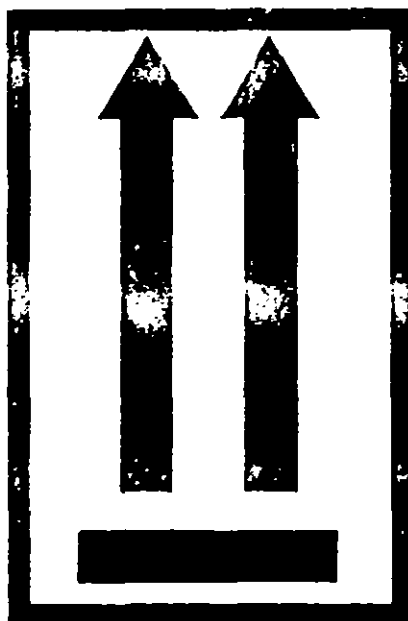
