The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following change are made:

1. Move the phrase "Keep Out of Reach of Children" and the signal word above the box which contains the precautionary statements and first aid.
2. Move the heading "An Insecticide-Fungicide for formulating Use Only" and the two sentences below the heading to the directions for use section below the misuse statement.
3. Delete the second entry for mustard (greens) within the Terrestrial Food Crops section.
