The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. - Automatic Seed Treaters Equipment that meters the proper amount of Granol N-M and uniformly mixes it as seed is suggered into the planter or drill box. Be sure to calibrate equipment to get the proper amount of Granol N-M on the seed.
- 2. Orlifor Planter Box Application Place and level one-half of the seed in the drill or planter box, then uniformly sprinkle over the seed one-half of the total GRANOL N-M required.
