

To suppress Seed Piece Decay (*Fusarium sambucinum*): Use 1 pound of this product per 100 pounds of whole or cut seed pieces. Apply for thorough coverage. Plant as soon after treatment as possible.

Seed-pieces that have been treated with this product that are then packaged or bagged for future use must contain the following labeling on the outside of the seed-piece package or bag:

"When opening this bag or loading/pouring the treated seed-pieces, wear: A) Long-sleeved shirt and long pants, B) Shoes, socks, C) Chemical resistant gloves, and D) a NIOSH-approved respirator with a dust/mist filter with MSHA/NIOSH approved number perfix TC-21C or any N, R, P, or HE filter.
