On the basis of information furnished by the registrant, the above named pesticide is hereby reregistered under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. Based on your response to the Reregistration Eligibility Decision, EPA has reregistered the product listed above. - 1. In the statement of ingredients, change the name used for the active ingredient from "Petroleum Oil" to "Mineral Oil" and footnote "Mineral oil" with a statement that reads "Contains petroleum distillates".

- 2. Revise the paragraph that appears under the heading "**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**" to read and appear as shown below.

CAUTION: Harmful if absorbed through skin. Avoid contact with eyes, skin or clothing. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals.

- 3. The sentence "Have the product container or label with you ... for treatment" appears in the table-wide cell at the top of the "**FIRST AID**" box and also in the table-wide cell with the subheading "**HOT LINE NUMBER:**". Delete that sentence from the top cell (which then will be empty and should be dropped from the table).
- 4. Under "**FIRST AID**", change the heading "**If on skin:**" to "**If on skin or clothing:**".
- 5. Change the order of treatments listed under "**FIRST AID**" to:

If on skin or clothing ...
If swallowed ...
If in eyes ...
If inhaled ...

Revise the "**If swallowed:**" statements by inserting the following text as the fourth bulleted item: "Do not give any liquid to the person."

- 6. In the phrase "**Only for Formulation into the following users:**", which begins the third paragraph of the "**DIRECTIONS FOR USE**" section, change "**users**" to "**uses**".
- 7. In the "**STORAGE AND DISPOSAL**" section, replace the subheading "**Storage:**" with "**Pesticide Storage:**". Revise the "**Container Disposal:**" and "**Non-refillable Container:**" paragraphs to be consistent with 40 CFR §156 Subpart H and PR Notice 2007-4, as revised April 29, 2008. Note that distinct statements regarding rinsing are needed depending upon the sizes of containers used and whether they are refillable. The master label must indicate the statements that are proposed to be used for each type and size range of container. As this product is for manufacturing purposes only, the statements used should not refer to application equipment.
- 8. Add your company's telephone number under the company name and address

Products shipped after 12 months from the date of this Notice or the next printing of your label, which ever occurs first, must bear the new revised label. Submit one copy of the final printed label before shipping this product bearing the new revised label.
