


- 1. Insert "IS" between "INSECTICIDE-MITICIDE" and "FOR" in the first sentence of the second paragraph under "DIRECTIONS FOR USE" (page 1, right column).
- 2. Under "Only for Formulation into the following uses:", change "Uses Patterns:" to "Use Patterns:"
- 3. In the first (left-hand) column of the table directly below "Use Patterns:", change "Bushberries, such as, but not limited to: Blueberry" to "Bushberries, including Blueberries". In the same column, replace "Caneberries, such as, but not limited to: Blackberry, Boysenberry, and Raspberry" with "Caneberries, including Blackberries, Boysenberries, and Raspberries".

A stamped copy of the label is enclosed for your records.

Submit two copies of final printed labeling before releasing this product for shipment under the labeling accepted via this letter.

If these conditions are not complied with, this registration will be subject to cancellation in accordance with FIFRA section 6(e).
