- b. Replace the Hazards to Domestic Animals and Humans section with "CAUTION: Harmful if swallowed. Wear long- sleeved shirt and long pants, socks, shoes and chemical resistant gloves (such as Natural Rubber, Selection Category A)".
- c. Since the toxicity category for Acute Dermal, Acute Inhalation, Primary Eye Irritation and Primary Dermal irritation are Category IV you may delete the "If in eyes, If on skin or clothing and If inhaled" precautionary statements from the First Aid section.

- 2. You must generate a one year storage stability and corrosion characteristics study corresponding to guideline 830.6317 on the proposed product. It is required that the observations be made at 0, 3, 6, 9, and 12 month intervals. The results must be submitted to the Agency in electronic and hard copy format.
- 3. You must submit and/or cite all data required for registration of your product under FIFRA Section 3(c)(5) when the Agency requires all registrants of similar products to submit such data, and submit acceptable responses required for registration review of your product under FIFRA.
- 4. Two copies of the finished labeling must be submitted prior to releasing the product for shipment. If you fail to comply with all of the **Terms of Registration** stated above, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e) and/or automatically expire. Construct and maintain a minimum 10-foot-wide vegetative filter strip of grass or other permanent vegetation between the field edge and down gradient aquatic habitat (such as, but not limited to, lakes; reservoirs; rivers; permanent streams; marshes or natural ponds; estuaries; and commercial fish farm ponds).

DEADLOCK™ G is a granular insecticide that controls infestations of the listed insects within the treatment zone.

The active ingredient in this product provides both curative and limited residual control of these insects. Some pests may have a single or multiple generations per year, depending on species, weather, and locale.

DEADLOCK G will control Armyworm, Cranefly, Cutworm, Sod Webworm, White Grub, and Wireworm.

APPLICATION DIRECTIONS

Grass Grown For Seed

Apply DEADLOCK G at a rate of 10 lbs, of product per acre. Distribute granules evenly in the furrow at planting time.

- Do not make more than one application of DEADLOCK G per crop per season.
- Do not apply more than 10 lbs. of product per acre per season.
- Do not plant a rotational crop within 30 days of the last application of this product.

Apply the specified amount of DEADLOCK G according to the following table. Calibrate the application equipment before use and periodically check to ensure that the equipment is working properly.
