DANGER

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Dilute with water to a suitable concentration of 1% to 8% by weight. To be impregnated into lumber, timber, ties, poles, posts, piling and plywood using standard impregnation processes and to standard retentions and penetrations of active ingredients as specified by the American Wood Preservers' Association. Solution concentration to be commensurate with wood species treated and the required retention. Refer to Osmose Operating Manual for specific recommendations. Do not use the treated wood product in any use which may violate regulations promulgated by the Food and Drug Administration.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container. Pesticide, spray mixture or rinsate that cannot be used or chemically reprocessed should be disposed of according to procedures approved by Federal, State and Local disposal authorities. Triple rinse (or equivalent) and dispose of in an approved landfill or bury in a safe place. Consult Federal, State or Local authorities for approved alternative procedures.
