# PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS (AND DOMESTIC ANMALS) DANGER

FATAL IF INHALED OR SWALLOWED USE ONLY WITH ADEQUATE VENTILATION OR RESPIRATORY PROTECTION

FATAL IF SWALLOWED, ABSORBED THROUGH SKIN OR INHALED, CORROSIVE, CAUSES IRREVERSIBLE EYE DAMAGE AND SKIN BURNS. Do not get in eyes, on skin, or on dathing, Do not breathe soray mist. Individuals who enter pressure treatment cylinders and other related equipment that is contaminated with the wood treatment solution (e.g. cylinders that are in operation or are not free of the treatment solution) must wear protective clothing, including overalls, jacket, gloves, and boots, impervious to the wood treatment formulation. In addition, individuals who enter pressure-treatment cylinders must wear properly fitting, well-maintained, high efficiency filter respirators; MSHANNOSH-approved for increasic arsenic, if the level of inorganic arsenic in the plant is unknown or exceeds 10 micrograms per cubic meter of air (10 Do/m<sup>3</sup>) average over an 8 hour work period. Air monitoring programs, procedures and record retention and submission must be conducted in accordance with the instruction on the attached labeling material.

Applicators must not eat, drink, or use tobacco products during those parts of the application process that may expose them to the wood treatment formulation (e.g., manually opening/closing cylinder doors, maying trams out of cylinders, mixing chemicals, and handling freshly treated wood).

Wash thoroughly after skin contact and before eating, drinking, use of tobacco products, or using restrooms.

Protective clothing must be changed when its shows signs of contamination. Applicators must leave protective clothing and workshoes or boots and equipment at the plant. Worn-out protective clothing and workshoes or boots must be left at the plant and disposed of in a manner approved for pesticide disposal and in accordance with state and federal regulations.

Individuals in the work area of an arsenical wood, treatment plant must wear properly fitting, well-maintained high efficiency filter respirators, MSHA/NIOSH approved for inorganic arsenic, if the level of inorganic arsenic in the plant is unknown or exceeds 10 micrograms per cubic meter of air (10 @g/m3) average over an 8-hour work period. Air monitoring programs, procedures and record retention and submission must be conducted in accordance with the instructions on the attached labeling material.

NOTE TO USER: Examples of acceptable materials for protective clothing (e.g. gloves, overalls, jackets, and boots) required during application and handling of inorganic arsenicals are vinyl, polyvinyl chloride (PVC), neoprene, NBR (Buna-N) rubber and polyethylene.

This product is toxic to wildlife. Do not contaminate streams, lakes, ponds, woodlands or similar areas. This product is highly toxic to bees and birds. #### **FIRST AID**

#### **DIRECTIONS FOR USE**

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

Osmose Arsenic Acid 75% is an end-use product to be used to formulate CCA Type A or Type C Wood Preservative Solutions when tank mixed with copper sulfate solution and sorium dich romate solution at the use site by commercial wood treating establishments.

Thise solutions are to be impregnated into forest products, such as lumber, timber, post, poles and piles using a vacuum pressurized system.

This product may only be used for preservative treatment of the following categories of forest products and in accordance with the respective cited standard (noted parenthetically) of the 2001 edition of the American Wood Preservers' Association Standards: Lumber and Timber for Salt Water Use Only (C2), Piles (C3) Poles (C4), Plywood (C9), Wood for Highway Construction (C14), Round, Half Round and Quarter Round Fence Posts (C16), Poles, Piles and Posts Used as Structural Members on Farms and Plywood Used on Farms (C16), Wood for Marine Construction (C18), Lumber and Plywood for Permanent Wood Foundations (C22), Round Poles and Posts Used in Building Construction (C23), Sawn Timber Used to Support Residential and Commercial Structures (C24), Sawn Crossams (C25), Structural Glued Laminated Members and Laminations Before Gluing (C28), Structural Composite Lumber (C33), and Shakes and Shingles (C34); and in accordance with the respective cited standard of the 2003 edition of the American Wood Preservers' Standards: Lumber, Timbers and Phywood for Cooling Towers (C-30). Forest products usested with this product may only he sold or distributed for uses within the AWPA Commodity Standards under which the treatment occurred.

## CCA TYPE C INSTRUCTIONS

To 2.610 gallons of water, add 4675 gallons of copper sulfate solution. Add 1,430 gallons of sodium dichromate solution. The final component to be added is 711 gallons of Osmose Arsenic Acid 75%. This yields a 20% concentrate.

#### CCA TYPE A INSTRUCTIONS

For a 1.5% working solution to one thousand gallons of water add 30 gallons of 25% copper sulfate solution. Add 13 gallons of 70% sodium dichromate solution. The final component is to add 2.6 gallons of Osmose Arsenic Acid 75%.

This is an end-use product intended to be tank-mixed at the use site by commercial wood treating establishments. The contents, which are for use only in pressure treating cylinders for forest products, cannot be used in concentrated form. Do not attempt to use without implementing the necessary safety equipment. To be used only in impregnation of forest products utilizing water solutions having concentrations ranging from 0.5% to 10% by weight. Impregnation procedures must rigidly adhere to the current standards of the American Wood Preservers association, as they pertain to type of wood products, wood species, penetration and retention levels, and other treatment method details.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE INSTRUCTIONS: OSMOSE ARSENIC ACID 75% should not be stored in tightly sealed, unlined metal containers (other than stainless steel) because of the possibility of excessive pressure developing from hydrogen liberation. Keep closures up to prevent leakage. Do not store in a manner where cross-contamination with other chemicals. food, or feed could occur. In the event of a spillage during handling or storage, soak up liquid with sawdust, clay, or other absorbent material and dispose of absorbant in accordance with the Pesticide Disposal Instructions listed below.

DISPOSAL INSTRUCTIONS: Wastes are acutely hazardous. Improper disposal is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control agency, or the Flazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
