Use ORD-X123 to control all types of wood decay and wood eating insects. ORD-X123 may be used to treat any wood product that will be exposed to conditions favorable to rot, decay and wood eating insects in above ground applications.

Contents for use only in pressure treating wood products. To be used only in vacuum pressure impregnation of wood products utilizing water solutions having concentrations ranging from 0.005 percent to 0.5 percent active ingredients by weight. The percent solution to be used should be based on the retention, in lbs., per cubic foot (pcf), specified by the purchaser and by the treating process used.

STORAGE AND DISPOSAL

Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat the procedure two more times. Offer for reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Tote Container:

Nonrefillable container. Do not reuse or refill this container. Empty tote container must be returned to a tote collection agent.
Residue Removal – Cleaning container before final disposal is the responsibility of the person disposing of the container.
