- b. Add "or using the toilet" to the second to last sentence of the Precautionary Statements.
- c. Delete "Empty tote container must be returned to a tote collection agent" in the Storage and Disposal statements for the Tote Container and state:

"Then offer for recycling if available or dispose of empty bag in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke."

DIRECTIONS FOR USE

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

This product has been developed to be used for treatment of wood products. Tank mix ORD-X070 with quaternary ammonium or azole compounds or other compounds approved for wood treatment. Do not attempt to use without having the necessary safety equipment. To be used only in treatment of wood products utilizing water solutions having concentrations ranging from 0.1 percent to 5.0 percent active ingredients by weight. Impregnation procedures must adhere to the current specifications of Osmose, Inc. or the American Wood-Preserver's Association. Processes used to apply ORD-X070 shall leave no visible surface deposits on the wood. Visible surface deposits mean a surface residue to crystallization on the treated wood. Small isolated or infrequent spots of chemical on otherwise clean wood shall be allowed. Treatment of wood products with ORD-X070 provides protection against termites, ascomycetes, white rot, brown rot, soft rot, and dry rot. The percent solution to be used must be based on the retention in lbs. per cubic foot (pcf) specified by the purchaser and by the treating process used.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Open dumping is prohibited. Keep container closed when not in use. Store in a dry, well ventilated area.

PESTICIDE DISPOSAL:

Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these pesticides cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER HANDLING:

Drums:

Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat the procedure two more times. Offer for reconditioning, if appropriate, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

Tote Container:

Nonrefillable container. Do not reuse or refill this container. Empty tote container must be returned to a tote collection agent. Residue Removal - Cleaning container before final disposal is the responsibility of the person disposing of the container. To clean container before final disposal, fill container about 10 percent full with water; agitate container vigorously; discard rinsate according to pesticide disposal instructions; repeat this rinsing procedure two more times.
