Subject: Label Amendment – To make the following changes to the label in response to the California Department of Pesticide Regulation (CDPR): Delete "Probable mucosal damage may contraindicate the use of gastric lavage." from the First Aid section. Add "Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals." to the precautionary statements section.

Dear Ms. Richardson:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. Pursuant to 40 CFR 156.10(a)(6) you must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. See FIFRA section 2(p)(2). If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the

Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Assurance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6. DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handles may be in the area during application. For any requirements specific to your State or Tribe, consult the State or Tribal agency responsible for pesticide regulation.

ORD-X209 may be applied by air or mechanical pressure pump [or by brush or roller]. ORD-X209 is designed for remedial treatment of in-service poles, poletops, bore holes, posts, beams, lumber, bridge and mine timbers and piling. ORD-X209 halts existing wood decay and protects against future decay.

Internal Treatment: Using air or mechanical pressure pump, apply solution to interior cavity of wood structure through prepared opening. Apply one gallon (maximum per cu. ft. of wood) or to refusal. [Product may also be applied as a foam by adding 3 to 8 ounces of foaming agent per gallon of mixed solution. Apply foam as to fill the void area and contact all wood surfaces in the void space.]

[Surface Treatment: ORD-X209 can also be applied by brush or roller to protect wood surfaces or end-cuts. Use one coat on materials to be finished with paint or stain. If no finish is to be used, apply two liberal coats within the hour. Thoroughly cover ends.]

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **PESTICIDE STORAGE:** Store in a secure, well-ventilated area protected from extreme temperatures. Do not transfer to unmarked containers. Keep container closed when not in use.

Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.
