It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This concentrate is designed for use undiluted in ULV sprayers which give particles of aerosol size. It can also be diluted with a suitable diluent for use in mechanical misting equipment such as the Microsol or Challenger machines which give larger particles. It can also be diluted with a suitable diluent and applied as a contact spray with mechanical misting equipment or pump sprayers. Before application, remove plants and pets from area to be treated.

NOTICE: If there is a need to treat such areas as conduits, motor housings, junction and switch boxes or other electrical equipment, de-energize electrical equipment prior to application. After application, allow time for oil to evaporate before starting motors or placing switches in the "ON" position.


For most effective results against flying insects, operate spraying dispenser adjusted to deliver a fine mist. For flying insects, use a 0.10% to 0.25% concentration.

TO KILL HOUSE FLIES, MOSQUITOES, GNATS, WASPS, HORNETS, and SMALL FLYING MOTHS: Close all doors and windows. Point nozzle upward, direct soray mist to all parts of the room, especially windows and other light sources which attract these insects. Fill the room with mist, then leave the treated area.
