## **DIRECT!ONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This concentrate is designed for use undiluted in ULV sprayers which give particles of aerosol size. It can also be diluted with a suitable diluent for use in mechanical misting equipment such as the Microsol or Challenger machines which give larger particles. It can also be diluted with a suitable diluent and applied as a contact spray with mechanical misting equipment or pump sprayers. Before application, remove plants and pets. from area to be treated.

NOTICE: If there is a need to treat such areas as conduits, motor housings, junction and switch boxes or other electrical equipment, de-energize electrical equipment prior to application. After application, allow time for oil to evaporate before starting motors or placing switches in the "ON" position.

In horse stables: Not for application if horses will be used for food. It is advisable to cover delicate furnishings when using this product undiluted.

# FOR USE IN ULV MECHANICAL AEROSOL GENERATORS:

Apply undiluted at the rate of 0.5 fl. ozs. (14.8 ml) of concentrate per 1,000 cu.ft. (28.3 cu. meters) of space. Direct output from aerosol generator upward toward upper corners of com and ceiling.
