TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. The place fogger in the center of the van with valve lock open, placing several layers of newspaper or pad under fogger. Leave the van at once and keep closed for 2 hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in 2 weeks or when necessary.

STORAGE: Store in cool dry area away from heat or open flame.

DISPOSAL: Replace cap & discard container in trash. Do not incinerate or puncture.
