Dear Mr. Klein:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. Revise front of the label-- replace "Inert Ingredients" with the phrase "Other Ingredients".
- 2. Delete "In case of contact flush with plenty of water." and "Obtain medical attention if irriation persists." from the Precautionary statement. These statements are covered under first aid section.
- 3. Replace "Wash with soap and warm water after use" with "Wash thoroughly with soap and water after handling."

Do not use in an area 5 ft. x 5 ft. or smaller. Turn off all ingnition sources. SHAKE WELL BEFORE USE. KEEP CONTAINER UPRIGHT. USE 2 AEROSOLS IN VANS OVER 30 FEET LONG. TREAT WHEN VAN IS EMPTY. TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger in the center of the van valve locked open, placing several layers of newspaper or pad under fogger. Leave the van at once and keep closed for two hours before aining out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited STORAGE: Store product in a cool dry place preferably a locked storage area. CONTAINER DISPOSAL: Do Not Puncture or Incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Many local governments collect these products.

STATEMENT OF PRACTICAL TREATMENT - FIRST AID

Have the product container or label with you when calling a poison control center or doctor, or going to treatment.

If swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. Call a poison control center or doctor for further treatment advice.
