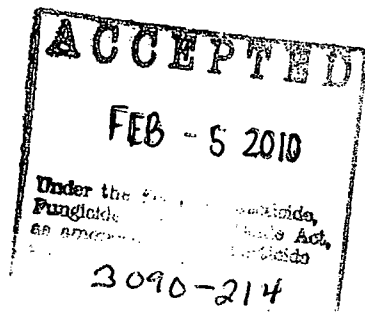
Do not use in an area 5 ft. x 5 ft. or smaller. Turn off all ignition sources. **SHAKE WELL BEFORE USE. KEEP CONTAINER UPRIGHT. USE 2 AEROSOLS IN VANS OVER 30 FEET LONG. TREAT WHEN VAN IS EMPTY.**
TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger in the center of the van with valve locked open, placing several layers of newspaper or pad under fogger. Leave the van at once and keep closed for two hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited
STORAGE: Store product in a cool dry place preferably a locked storage area.

CONTAINER DISPOSAL:

STATEMENT OF PRACTICAL TREATMENT - FIRST AID
