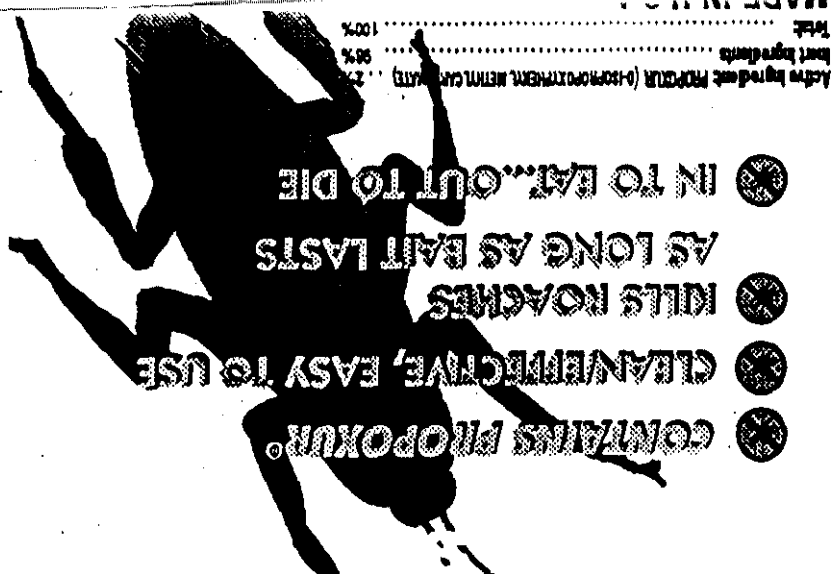

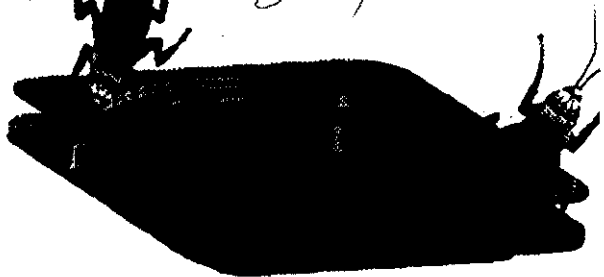

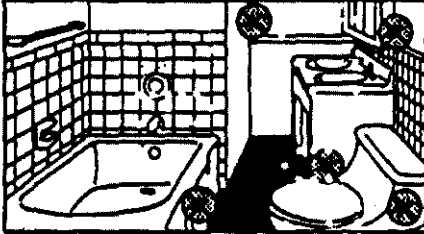

2. Place roach discs primarily in kitchen area and bathrooms. Also place near areas where roaches have been. Other areas might include the pantry, utility room, near exposed plumbing fixtures, windows and doors. Under sinks, in corners, under stoves or refrigerator, in cabinets.
3. Roaches will feed on the bait and generally return to their hiding to die.
4. Replace all roach discs every 2 months to keep roaches from returning.
