CONTINUING TO SPRAY UNTIL THE NEST OR THE AREA SPRAYED IS COMPLETELY SATURATED. APPLICATION AT NIGHT AFTER THE INSECTS HAVE RETURNED TO THEIR NEST IS PREFERABLE, REPEAT AS NECESSARY, A SPRAY FROM 16 FEET OR MORE AWAY DIRECTED INTO NESTS, CREVICES, HOLES WILL KILL WASPS, HORNETS, BEES, YELLOW JACKETS.
