The labeling referred to above, submitted in connection with registration under the Federal Insecticide, and Rodenticide Act, amended, is acceptable subject to the comments listed below:

1, In accordance with PR Notice 2001-6, Revise your Storage and Disposal Statement to Read:

IF Empty: Do not reuse this container. Place in trash or offer for recycling if available.

IF Partly Filled: Call your local solid waste agency or
[toll free number meet the criteria in
paragraph II.E.] for disposal.
instructions. Never place unused product
down any indoor or outdoor drain.

2. Revise your product label per the Efficacy/Entomologists comments and recommendations:

-The studies fulfill the product performance requirements for the proposed label claims.

-Add (excluding fire ants and carpenter ants) on the front panel in the bullet naming the pest ant species.

-Change "Odorous ants: to read "Odorous House ants".

-Remove the claim "long term control".

-In directions for use section on page 2, change the italicized sentence to read: "In approximately 7-10 days the bait will start killing ants. Baiting may be required for up to 2 months to kill all ants in a colony." This is the type of claim supported by your data. You might want to clarify such claims by discussing that the active ingredient is slow-acting.

Page No. 2 EPA Reg. No. 3095-47

-Queen/colony killing claims: Add: it may take up to two months to kill all queens in the baited colonies.

-A specific delivery device is mentioned in the studies -"The Ant Café". The label should state a specific device if required. However, the holes in the Ant Café are not for use with large ant species. It might be helpful to describe the type of device to be used with this product - on the label.

-In the future, the results of the statistical analyses should be more clearly presented and should include confidence intervals. The tables are helpful but can also be confusing without more explanation The graph were done well.
