Remove cap at tip of barrel of the pre-filled, disposable syringe then apply paste by pushing down the plunger into cracks and crevices only in area not easily accessible to children and pets. Do not apply paste where it might come in contact with surfaces and open food. Use PIC Roach Control Paste as a spot or crack and crevice treatment for the control of cockroaches in and around home; non food areas of institutions, warehousing and commercial buildings; telephone facilities, sewers, garbage areas, on buses, trains, planes, ships. Apply paste near aggregation and harboring areas. Use under surface of counters, tables, shelving, drawers, under sinks around pipe collars, under refrigerators, stoves, electrical boxes and computer housing. Keep record of area to which applied. Reapply in 1-2 weeks if no bait is visible. Use a number of smaller spot applications for quicker control rather than a few large spots.
