DIRECTIONS FOR USE

DI-SYSTEM is a systemic insecticide that enters the plant through the root system. The insecticide when placed near, the roots, is picked up and moves in the sap stream to all parts of the plant, where it kills insects as they feed on the plant.

POTATOES: For the control of Aphids, Flea Beetles (except tuber flea beetles), Leafhoppers, Colorado Potato Beetles (early season reduction), Southern Potato Wireworm, apply at

Rate of 400 to 600 lb (23% actual insecticide) per acre.

Apply as a furrow treatment at the time of planting or as a side dressing. Do not apply within 75 days of harvest. Higher rate to be used in organic soils.

SUGAR BEETS: For the control of Aphids, Leafhoppers and Mites, apply at Rate of 200 lb (1 lb actual insecticide) per acre.

Do not apply within 30 days of harvest. Do not apply directly on the seed.

READ "IMPORTANT" STATEMENT BELOW

IMPORTANT: When used on sugar beets at the maximum recommended rates under adverse conditions such as extremely cool and wet or extremely dry weather, this product may cause some delay in emergence, stunting of seedling, or reduction of stand. Such damage may be more pronounced in light, sandy soils. Plant injury may also occur or may be enhanced when certain pre-emergence herbicides are used in conjunction with the product.
