Three applications, at monthly intervals, may be required for maximum control of sod webworm. In most areas the first of these applications should be made in May or June. Two treatments, two to three weeks apart, may be required for chinch bug control. Consult local authorities for more specific information regarding timing of applications.

DYLOX Lawn and Turf Insecticide dissolves in water to form a solution. It can be applied by watering can, compressed air sprayer and all commercial power sprayers. Do not use in hose projection sprayers.

SOD WEBWORM CONTROL: Mix 4 to 6 ounces (approximately 3/4 to 1 cup) of DYLOX Lawn and Turf Insecticide in 10 to 15 gallons of water and apply uniformly to 1,000 square feet of lawn area. For best results use the lawn roller method of application. Water the lawn thoroughly and allow grass to dry before spraying. Do not water again until necessary. Repeat application as necessary at regular intervals.

CHINCH BUG CONTROL (Provide On): Apply 4 ounces (3/4 cup) of DYLOX Lawn and Turf Insecticide per 1,000 square feet. For best control, when using a compressed air sprayer or watering can, use 30 to 40 gallons of water per 1,000 square feet. Commercial application with power sprayers should not use less than 15 gallons per 1,000 square feet. Repeat treatments as necessary at 2 to 3 week intervals.
