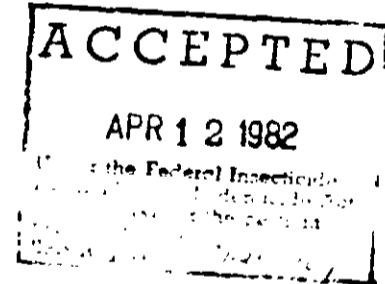

The granular should be broadcast over bench or bed area and thoroughly worked into the soil, or used as a total incorporation by mixing soil and granular thoroughly in any suitable mixing equipment.
