(2) Add the Following:

MIXING: The enclosed packets containing MORESTAN 25% Wettable Powder are water soluble. Do not allow packet to become wet prior to adding to the spray tank. Do not handle with wet hands. Reseal outer bag to protect remaining packets.

To prepare the spray mixture, merely drop the required number of unopened packets, as determined under "Recommended Application", into the spray tank while filling with water to the desired level. Operate the agitator while mixing. Depending on the water temperature and the degree of agitation, the packets should be completely dissolved within approximately 5 minutes from the time they were added to the water.

DOSAGE: Use specified dosage of MORESTAN 25% Wettable Powder in the designated amount of water necessary to give complete coverage of foliage. Determine the total amount of wettable powder to be added to the spray tank based on the rates under "Recommended Applications". For each 1/2 pound (8 ounces) of wettable powder to be added to the spray tank use one 8-ounce packet. For example, if it is determined that 1-1/2 pounds (24 ounces) of MORESTAN 25% Wettable Powder should be added to the spray tank, add three 8-ounce packets. The type of equipment used will determine the concentration required; however, use of these packets is not recommended for making highly concentrated mixtures such as used in aircraft spraying.
