Your Letter Dated February 4, 1987

The amendment referred to above, submitted in connection with reregistration under Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable provided that you:

- Make the labeling changes listed below before you release the product for shipment bearing the amended labeling.
  - a. The "Precautionary Statements" heading should follow the signal word. (Pretains to 3128-130 only.)
  - b. Note: The child hazard warning and signal word should be 12-point and 18-point type, respectively.

d. Revise the Statement of Practical Treatment subheadings as follows:

"If On Skin: . . . and warm water. Get medical attention immediately."

"If In Eyes: Wash with plenty of flowing water. Get medical attention immediately."

- e. The subheading "To Physician" should read "Note To Physician."
- f. Revise the sentence to read, "... and may be administered, but only in conjunction with atropine."
- 2. Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your/release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the labeling is enclosed for your records.

DI-SYSTON systemic insecticide enters the plant by absorption through the roots. The insecticide placed near the roots is translocated to all parts of the plant and kills sucking insects feeding on the plant.

The formulation of DI-SYSTON Liquid Concentrate is highly versatile and offers many forms of application. It can be sprayed or injected into the furrow at planting time or soil injected as a side-dress treatment at planting time or after plants become established. Applications may be made in water emulsion, with liquid fertilizer, or undiluted in specially designed equipment for low volume soil injection but never on crops for which less than I quart liquid concentrate per acre is the recommended dosage. When mixing with

certain liquid high phosphorous fertilizers, the use of COMPEX compatibility agent or other equivalent agents at the rate of 1 quart per 100 gal. of mixture may be needed to assure proper mixing. Time and method of application and limits for use are discussed in detail for each specific crop under "Remarks" below.

IMPORTANT: When used on cotton, tomatoes, beans, or lettuce at the maximum recommended rates under adverse conditions such as extremely cool or wet or extremely dry weather, DI-SYSTON may cause some delay in emergence, stunting of seedlings, or reduction of stand. #### SPRINKLER IRRIGATION APPLICATION TO POTATOES:

For control of green peach aphid, and Colorado potato beetle on potatoes in the States of California, Oregon, Washington, Idaho, and Utah apply DI-SYSTON Liquid Concentrate at the rate of 1-1/3 to 4 pints per acre through sprinkler irrigation systems. Use only in solid set or center pivot systems equipped with automatic shutoff devices and valves to prevent backflow into the water source. Do not apply when wind velocities exceed 10 mph.

#### Solid Set Calibration:

- (1) Determine the area to be treated per irrigation set. If one set irrigates four 1/4 mile long lines on a 50' spacing, 4 x 1,320' x 50 feet = 264,000 square feet or approximately 6 acres.
- (2) If 1-1/3 pints of DI-SYSTON Liquid Concentrate is to be applied per acre, 6 x 1-1/3 or 8 pints (1 gallon) of DI-SYSTON Liquid Concentrate is needed.
- (3) Bilute with sufficient water so injection time will require approximately 30 minutes or more per set. Under no circumstances should injection be less than 10 minutes.

#### NOTE:

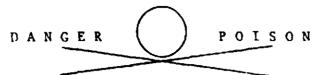

HAZARDS TO HUMANS AND DOMESTIC ANIMALS



Poisonous if swallowed, inhaled, or absorbed through the skin. Rapidly absorbed through the skin. Do not get in eyes, on skin, or on clothing. Wear protective clothing, natural rubber gloves, and goggles.

Do not breathe fumes or spray mist. Wear a pesticide respirator jointly approved by the Mining Enforcement and Safety Administration (formerly the U.S. Bureau of Mines) and by the National Institute for Occupational Safety and Health under the provisions of 30 CFR Part 11.

(Contaminated articles which should be discarded would include: hats, gloves, aprons, coats, boots, etc. not made of rubber or coated with rubber or other similar materials). Clothing receiving spray mist or droplets from the mixed, diluted DI-SYSTON Liquid Concentrate should be removed and decontaminated before reuse. This clothing can be decontaminated by machine washing separately from other items with soap or detergent and bleach in hot water twice before reuse. Protective clothing and equipment should be washed down with detergent or soap and bleach in water. Wash water from the cleaning of protective clothing or equipment should not be allowed to run off or otherwise enter water supplies.

SYMPTOMS OF POISONING: A sense of "tightness" in the chest. Sweating. Contracted pupils. Stomach pains. Vomiting and diarrhea.

#### STATEMENTS OF PRACTICAL TREATMENT

In case of poisoning, call a physician immediately. Have patient lie down and keep quiet. If s allowed, vomiting should be induced. Administer water freely and induce vomiting by giving one dose (1/2 oz. or 15 ml.) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down thro the epeat until vomit fluid is clear. Never give anything by mouth to an unconscious pear. Professional medical assistance should be secured immediately. If on skin, remove contaminated clothing and wash skin immediately with soap and warm water. If eves are contaminated, wash with flowing water for at least 15 minutes.

#### STATEMENTS OF PRACTICAL TREATMENT (Cont'd)

#### TO PHYSICIAN:

ANTIDOTE - Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance. 2-PAM is also antidotal and may be administered in conjunction with atropine.

Compound inhibits cholinesterase resulting in stimulation of the central nervous system, the parasympathetic nervous system, and the somatic motor nerves. Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.

#### ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and wildlife. Do not apply directly to water or wetlands. Drift and runoff from treated areas may be hazardous to fish in neighboring areas. Do not contaminate water by cleaning of equipment or disposal of wastes. Cover or incorporate spills.

This pesticide is toxic to bees exposed to direct application. Applications should be timed to coincide with periods of minimum bee activity, usually between late evening and early morning.
