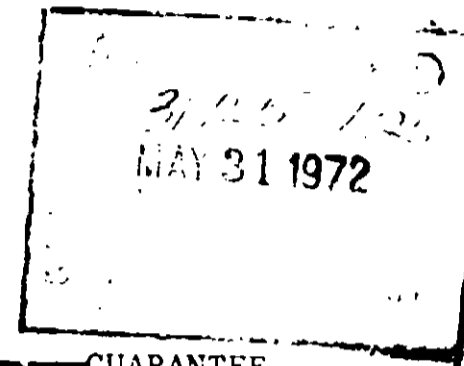

For control of snow mold (Typhula sp.), apply DYRENE 5% Granular at the rate of 4 pounds per 1,000 square feet after the first killing frost in the fall. A second application should be made when the greens, tees, fairways, and other turf areas are free of snow in mid-winter, and this should be followed by a third application after the final melting of snow in late winter or early spring.

CAUTION

Harmful if swallowed or inhaled. Avoid contact with eyes, skin, or clothing. Avoid breathing of dust. Wash thoroughly with soap and warm water after handling. Wash contaminated clothing with soap and hot water before reuse.

Do not contaminate feed or food. Keep out of reach of children.
