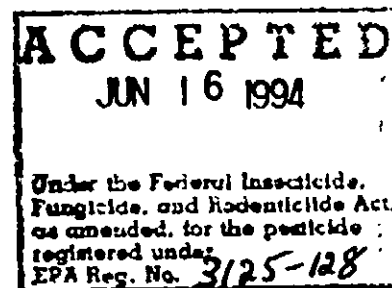

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS

Poisonous if swallowed, inhaled, or absorbed through the skin. Rapidly absorbed through the skin. Do not get in eyes or on skin. Wear protective clothing, natural rubber gloves, and goggles. Do not breathe dust. Wear a mask or respirator jointly approved by the Mining Enforcement and Safety Administration (formerly the U.S. Bureau of Mines) and by the National Institute for Occupational Safety and Health under the provisions of 30 CFR Part 11. Keep all unprotected persons out of the operating area or vicinity. Wash hands, arms, and face thoroughly with soap and warm water before eating or smoking. Wash all contaminated clothing with soap and hot water before reuse.

SYMPTOMS OF POISONING: A sense of "tightness" in the chest. Sweating. Contracted pupils. Stomach pains. Vomiting and diarrhea.



STATEMENTS OF PRACTICAL TREATMENT

If swallowed, vomiting should be induced. Administer water freely and induce vomiting by giving one dose (1/2 oz. or 15 ml.) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. Never give anything by mouth to an unconscious person. Professional medical assistance should be secured immediately.

If inhaled, remove victim to fresh air. Apply artificial respiration if indicated.

If on skin, remove contaminated clothing and wash affected areas with soap and water.

If in eyes, flush eyes with plenty of water. Call a physician if irritation persists.

Note to Physician: Gastric lavage may be indicated if product was taken internally. Disulfoton is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish and wildlife. Do not discharge effluent containing this active ingredient into lakes, streams, ponds, estuaries, oceans or public waters unless this product is specifically identified and addressed in an NPDES permit. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Terrestrial, food uses on:

Beans, Brussels sprouts, cauliflower, broccoli, cabbage, lettuce, peas, potatoes.

Domestic outdoor use on:

Potted plants, ornamentals (herbaceous plants, flowers, woody shrubs, trees)

Domestic indoor use on:

Potted plants, ornamentals (specified above)

Greenhouse non-food use on:

Ornamentals (specified above)

STORAGE AND DISPOSAL

Pesticide Disposal: Do not contaminate water, food or feed by storage or disposal.
