However, because of the wide range of conditions under which this product may be used, even though label directions are followed, it is impossible to eliminate all risks associated with its use because of abnormal conditions beyond the control of the seller. Chemagro and the Seller offer, and the Buyer uses, this product subject to the understanding that the Buyer assumes all such risks.

GUTHION 10% Granular insecticide is very effective for control of the sugarcane borer. GUTHION 10% Granular may be applied by aircraft at any time during the day provided wind conditions are relatively calm. Aircraft should be flown at a height that will insure uniform coverage. Consult your State Agricultural Extension Service or Experiment Station for specific information regarding timing of applications.

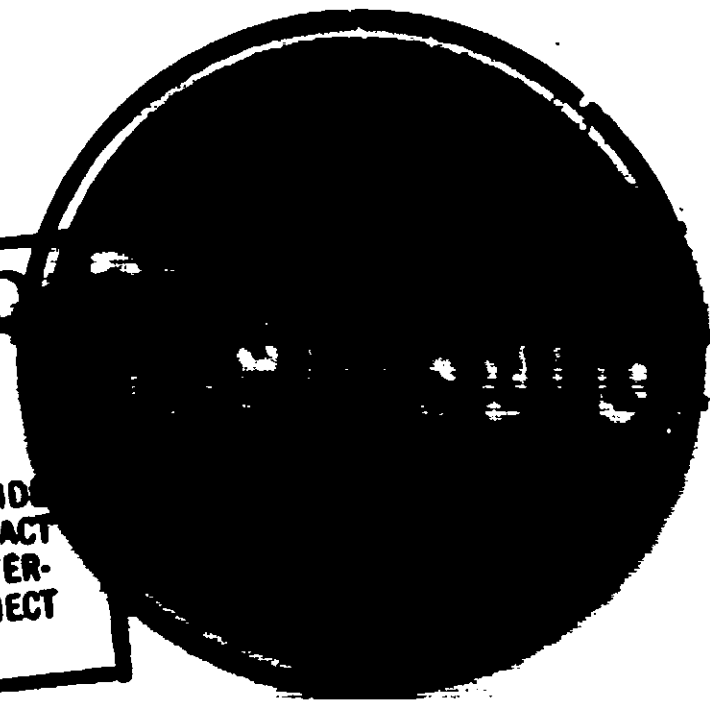

Sugarcane	Sugarcane borer	10	Apply specified dosage per acre as a broadcast application. Do not apply more than 5 times per season nor with 30 days of harvest. Bagasse from sugarcane treated with GUTHION may be used as feed for cattle, sheep, and goats. Consult your State Agricultural Extension Service or Experiment Station for specific use information in your area.

RESTRICTIONS

Do not use on other crops used for food or forage. Do not feed treated forage and harvest trash to livestock. Use only according to label directions. Applications at rates above those shown may result in illegal crop residues.
