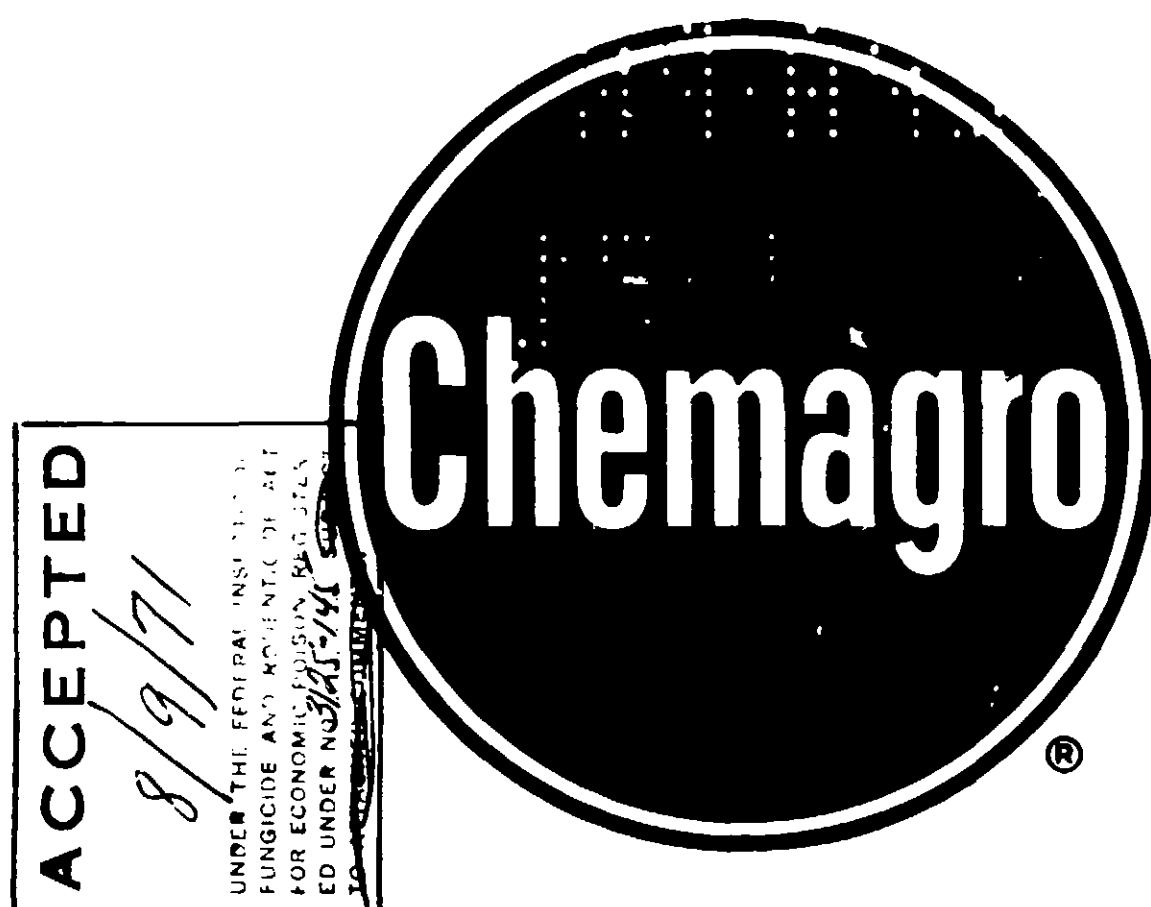

However, because of the wide range of conditions under which this product may be used, even though label directions are followed, it is impossible to eliminate all risks associated with its use because of abnormal conditions beyond the control of the seller. Chemagro Corporation and the Seller offer, and the Buyer uses, this product subject to the understanding that the Buyer assumes all such risks.

DEXON+TERRACLOR Dust, a combination of two very effective fungicides, is recommended for the control of cotton seedling diseases.

For Planter Box Application: Use 10 pounds of DEXON+TERRACLOR Dust per 100 pounds of re-ginned or mechanically delinted seed. Apply through the planter box at planting time. DEXON+TERRACLOR Dust should be thoroughly mixed with the seed prior to filling the planter box. Calibrate planter with treated seed to insure accurate seeding rates. This product is not recommended for use with acid delinted cotton seed.

RESTRICTIONS

Do not use on other crops used for food or forage. Use only according to label directions. Application at rates above those shown may result in illegal crop residues.
