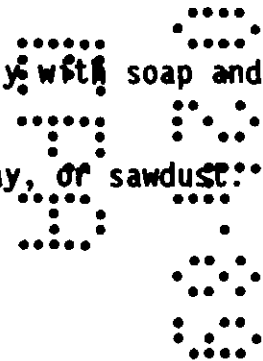

CONTAINER DISPOSAL

DO NOT REUSE THE CONTAINER. Completely empty the contents and bury the unused, chemical at least 18 inches deep in an isolated location away from water supplies. Rinse empty container by flushing with a solution of water and household lye (3 tablespoons lye per 1 gallon of water). Bury rinse solution at least 18 inches deep in an isolated area away from water supplies. Punch holes in the top and bottom of the container, crush container, and bury deeply in an isolated location.
