

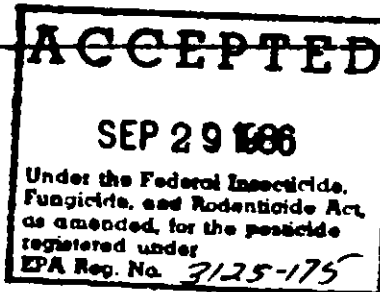

KEEP OUT OF THE REACH OF CHILDREN

DANGER

Causes irreversible eye damage. Harmful if swallowed. Do not get in eyes or on clothing. Avoid contact with skin. Wear goggles, face shield, or safety glasses. Wash thoroughly with soap and warm water after handling. Remove and wash contaminated clothing with soap and hot water before reuse.

NOTE: Protective clothing should be worn during periods of exposure, such as during formulation or when contacting treated foliage. DYRENE anilazine may cause an allergic skin reaction in some susceptible persons. This condition should be treated as an allergic dermatitis.

STATEMENTS OF PRACTICAL TREATMENT

If in eyes: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

If on skin, wash immediately with soap and warm water. If irritation occurs, get medical attention.

If swallowed, drink promptly a large quantity of milk, or if milk is not available, large quantities of water. Avoid alcohol. Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage.

ENVIRONMENTAL HAZARDS

This product is toxic to fish and aquatic invertebrates. Do not discharge effluent containing this product directly into lakes, streams, ponds, estuaries, oceans or public waters unless this product is specifically identified and addressed in an NPDES permit. DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DYRENE 80% Dry Concentrate is for formulation into end use fungicide products intended for domestic and non-domestic outdoor terrestrial use on strawberries, celery, onions (green, bulb, dry), garlic, potatoes, tomatoes, gladiolas, lawn and turf.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Do not use container in connection with food, feed, or drinking water. Completely empty container into processing equipment. Then dispose of empty container in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food, and feed. Store in original container and out of the reach of children, preferably in a locked storage area.

Handle and open container in a manner as to prevent spillage. If the container is leaking or material spilled for any reason or cause, carefully sweep material into a pile. Refer to Precautionary Statements on label for hazards associated with the handling of this material. Do not walk through spilled material. Dispose of pesticide as directed above.
