DANGER

STATEMENTS OF PRACTICAL TREATMENT

If in eyes: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention.

If on skin, wash immediately with soap and warm water. If irritation occurs, get medical attention.

If swallowed, drink promptly a large quantity of milk, or if milk is not available, large quantities of water. Avoid alcohol. Note to Physician: Probable mucosal damage may contraindicate the use of gastric lavage.

ENVIRONMENTAL HAZARDS

DYRENE 80% Dry Concentrate is for formulation into end use fungicide products intended for domestic and non-domestic outdoor terrestrial use on strawberries, celery, onions (green, bulb, dry), garlic, potatoes, tomatoes, gladiolas, lawn and turf.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Disposal: Do not use container in connection with food, feed, or drinking water. Completely empty container into processing equipment. Then dispose of empty container in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. ~~If burned, stay out of smoke.~~
