How to Apply:

Place in artificial burrows made with suitable burrow building equipment. Use 1-1/2 lbs. of GOPHACIDE 0.1% Bait per acre in burrows spaced at 20-foot intervals or 1 lb. per acre in burrows spaced at 30-foot intervals. Treatment may also be made to natural burrows at the rate of 1-1/2 lbs. of GOPHACIDE 0.1% Bait per acre of area to be treated.

WARNING (Cont.)

If poisoning occurs, obtain prompt medical aid. Prolonged exposure will result in cholinesterase depression. If swallowed, vomiting should be induced. Administer milk or water freely and induce vomiting by giving one dose (1/2 oz. or 15 ml.) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. Never give anything by mouth to an unconscious person. If eyes are contaminated, wash with flowing water for at least 15 minutes.

ANTIDOTE: Although atropine may be less effective as an antidote with this than with some other organic phosphorus compounds, it should be used in large therapeutic doses in cases of acute poisoning. Repeat as necessary to the point of tolerance.
