BAYLUSCIDE - TFM Wettable Powder has proved to be an excellent treatment for control of sea lamprey eel larvae (*Petromyzon marinus*) in tributaries flowing into the Great Lakes. Each stream selected for treatment must first be bioassayed to determine both the minimum concentration of BAYLUSCIDE-TFM required to kill lamprey larvae and the maximum concentration that can be applied without causing fish mortality. Lethal concentrations will vary, depending upon water hardness and temperature. Carefully calculate stream flow-rate and add the concentration of BAYLUSCIDE-TFM necessary to kill lamprey larvae, providing such concentration falls below that which can be applied without killing fish. Applications of BAYLUSCIDE will kill fresh water clams and mussels. Consult your State Fish and Game Agency before applying this product. Use only as directed on this label.

**DO NOT RE-USE CONTAINER** - Destroy container by burying with waste or by burning. Stay away from smoke or fumes.

DANGER

For use by trained operators only. May be fatal if swallowed or absorbed through skin. Avoid contact with skin and eyes. May produce severe burns; care must be exercised in handling the concentrated forms of the larvicide. Protective clothing, rubber gloves, and face masks are necessary for the minimum protection of handlers. Wash thoroughly after handling.

**NO KNOWN EFFECTIVE ANTIDOTE:**

In case of poisoning, call a physician immediately. Have patient lie down and keep quiet. If swallowed, vomiting should be induced. Administer milk or water freely and induce vomiting by giving one dose (1/2 oz. or 15 ml.) of syrup of ipecac. If vomiting does not occur within 10 to 20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. Never give anything by mouth to an unconscious person. Professional medical assistance should be secured immediately.
