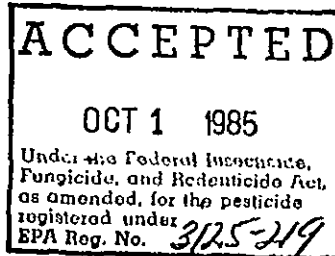

BAYLUSCIDE 5% Granular has proved to be a useful tool for determining populations of sea lamprey larvae in waters in the Great Lakes basin and the Lake Champlain system. The granules, when applied to areas to be surveyed, fall rapidly to the bottom where they give excellent kill of lamprey eel larvae.

Apply 100 pounds of BAYLUSCIDE 5% Granular evenly over each surface acre of water (2-1/3 pounds/1,000 square feet). Use equipment that can be accurately calibrated to distribute the required amount of granular evenly over the area to be treated.

When applied as directed, BAYLUSCIDE 5% Granular will not harm game fish populations that may be present in treated waters. Application will kill freshwater clams and mussels and may kill fish species that are physiologically bound to the stream bottom.

STORAGE AND DISPOSAL

**Pesticide Disposal:** Do not contaminate water, food or feed by storage or disposal.

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

**Container Disposal:** Do not use container in connection with food, feed, or drinking water. Completely empty container into application equipment. Then dispose of empty container in a sanitary landfill or by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.

Store in a cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food and feed. Store in original container and out of the reach of children, preferably in a locked storage area.
