## **DIRECTIONS FOR USE**

IMPORTANT: Read these entire Directions and Conditions of Sale, including the Warranty and Limitation of Damages provision, before using MESUROL 2% Bait.

CONDITIONS OF SALE: These Directions for Use reflect the opionion of experts based on tests of effectiveness, and toxicity to laboratory animals under normal conditions of use. However, because of the wide range of conditions under which this product may be used, even though label directions are followed, it is impossible to eliminate all risks associated with its use because of abnormal conditions beyond the control of the seller. Chemagro and the Seller offer, and the Buyer uses, this product subject to the understanding that the Buyer assumes all such risks.

MESUROL 2% Bait is very effective for the control of slugs and snails around the home, in flower gardens, and in ornamental greenhouses. The bait should be applied to soil around plants but not directly to plant foliage. CAUTION: Do not use around food crops.

Sprinkle 1 pound of MESUROL 2% Bait uniformly over 1000 square feet of area to be treated. For best results lightly water the area to be treated before applying the bait. When making applications, special attention should be given to treating areas around flower beds, under greenhouse benches and around building foundations. Repeat applications as necessary to keep areas free of slug and snail pests.

**RESTRICTIONS:** Do not use on plants grown for food. Do not put bait in piles. Scatter bait so that it is hardly visible on the ground.

FISH AND WILDLIFE CAUTIONS: This product is toxic to fish and wildlife. Keep out of lakes, ponds, or streams. Birds feeding on treated areas may be killed. Do not contaminate water by cleaning of equipment, or disposal of wastes. Apply this product only as specified on this label.
