CONDITIONS OF SALE: These Directions of Use reflect the opinion of experts based on tests of effectiveness under normal conditions of use. However, because of the wide range of conditions under which this product may be used, even though label directions are followed, it is impossible to eliminate all risks associated with its use because of abnormal conditions beyond the control of the seller. Chemagro and the Seller offer, and the Buyer uses, this product subject to the understanding that the Buyer assumes all such risks.

BAYGON 1% HOUSEHOLD INSECT RESIDUAL SPRAY is a highly effective new formulation which provides rapid kill of such crawling insects as listed below, including those resistant to certain chlorinated hydrocarbon and phospate insecticides; ants, brown dog ticks, clover mites, crickets, earwigs, finas, flies, hornets, millipedes, mosquitoes, roaches, saw-toothed grain beetle (exposed stage), scorpions, silverfish, sowbugs, spiders, and

In addition to rapid initial kill, the spray stays on treated surfaces and kills indoor pests for up to 2 weeks after the spray deposit has dried.

HOW TO USE: Spray infested surfaces until wet, moving the spray rapidly to prevent excessive wetting of surfaces, and waste of material. Point spray away from people, plants, and pets.

INDOOR USE: ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS, SAW-TOOTHED GRAIN BEETLES (EXPOSED STAGE), WATERBUGS: Spray into cracks, crevices, around baseboards, and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. For ants, spray trails and places where ants may enter premises. Repeat as needed. Do not spray foodstuffs or house plants. Remove pets and cover fish bowls before spraying. Do not allow children to contact treated surfaces until sufaces are completely dry. Dispose of infested foodstuffs.

Do not use in edible products areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed. When using in food processing plants, apply only in the inedible product areas where no exposed food or processing equipment is present, taking needed precaution to avoid contamination of packaged or stored commodities.

BROWN\_DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Fresh bedding should be places in animal quarters after spraying. Do not spray animals.

OUTDOOR USE: ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, FLIES, HORNETS, MILLIPEDES, MOSQUITOES, SOWBUGS, WASPS, and BROWN DOG TICKS: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills, and runways. For control of wasps and hornets apply after dark when all of the insects have returned to the nest. Repeat as necessary. Do not spray vegetation,

RESTRICTIONS: Do not apply to rugs, carpets, draperies, wallpaper, or similar materials that may be stained. Avoid excessive wetting of plastic, rubber, and asphalt surfaces such as tiles and floor coverings.

WARNING-FLAMMABLE: Do not spray into or near open flame. Do not smoke while using. Keep container away from stoves, radiators, or other hot surfaces. Do not place in direct sunlight. Temperatures exceeding 1200 F, may cause the container to burst. Do not puncture or throw container into
